In February and March 2005 , panels of the Investigating Committee considered 26 cases, they found a case to answer in 16 cases and no case to answer in 8 cases. There are a further 48 cases awaiting a panel.

Conduct and Competence Committee

There are currently 87 cases within the remit of the Conduct and Competence Committee, of this number 28 cases will require a review hearing and hearing dates have been set in 18 cases. A Conduct and Competence Panel case was not well founded in February 2005

Health Committee

There are currently 13 cases within the remit of the Health Committee of this number Of this number 6 cases require a review hearing and dates for 6 hearings have been fixed

Interim Orders

In February and March, 5 Interim Orders were applied for and 4 were granted. A review of an interim order also took place

Registration Appeals
