They also noted that the HCPC requires information about the monitoring of practice based learning to be provided via annual monitoring, which should ensure that visitors can review this area in the detail required to ensure the standards continue to be met by the programme.</p> <p>They considered that undertaking an audit in the 2021-22 academic year would allow the education provider to gather evidence related to practice-based learning for years 2 and 3 of the programme.</p>
